13. General	The submission of the entry to a race is a confirmation that the registered boat meets all the associated requirements and regulations. It is valid as a confirmation that the registered sailor are eligible and agree to the special conditions for this race. For fax and on-line registrations of sailors under 18 years of age: a confirmation of the message with the signature of the parent or guardian is to be presented to the race committee before the 1st start, otherwise the race committee can exclude the participant from the event. The acceptance of the message is not confirmed. If the event does not take place, the participant will be notified in writing, by telephone, by fax or e-mail after the closing date. The registration fee will be reimbursed in this case, unless the organizer offers a replacement regatta for another appointment. The race committee reserves the right to let the race committee to refuse according to Art. Rule 76 WR. The race committee reserves the right to verify the existence of the existing liability insurance (minimum sum insured 3.5 million €) for the registered boat and to exclude the participant from

The claim to payment of the registration fee is not canceled by the withdrawal of the report or by staying away from the race. The entry fee will only be refunded if the message is rejected.
